



Submission Guidelines: Under 18s

Saatchi Gallery Learning is thrilled to offer the opportunity to showcase works created by schools and community groups. Students of all ages are invited to submit their artworks inspired by the Gallery's current exhibitions. Each month we will choose our favourite submissions for our *Student Artworks of the Month*, with winning entries celebrated on [Saatchi Gallery Learning Instagram](#) and [online gallery](#). There is also the opportunity for your group's work to be displayed to the public in our onsite Learning Gallery situated on the top floor – please email education@saatchigallery.com for further information.

Please note that for children under the age of 18, work should be submitted either by their school/group or by a parent/guardian along with a completed permission form (see below). Additional consent will be needed from a parent/guardian for any individual under 18 who is identifiable in the artwork if not the artist.

Each image must be saved as a JPG/JPEG and be smaller than 3 MB.

For your chance to be selected, please submit a maximum of three artworks per group, or one per individual, to one of the following places (please choose only one platform):

Terms and conditions

By submitting your students' work, you confirm that the contributions are their own original work, are not defamatory and do not infringe any UK laws. By submitting work to Saatchi Learning Gallery, you confirm that the consent of a parent / guardian for artists under eighteen has been given. Proof of consent is also required for anyone under the age of eighteen who is identifiable in the work (if that person is not also the artist). Consent will need to be supplied before such work is displayed in the Saatchi Gallery's online Learning Gallery or social media sites. Saatchi Gallery will not disclose any information that may identify any child under the age of 18 through the work they have submitted such as their full name, social media handle, exact address, school or name of any other organisation with which they are associated. By submitting your work to the Learning Gallery, you confirm that the Saatchi Gallery may reproduce images for the purposes of marketing and promotion, including use on the Saatchi Gallery website and social media sites. The artist will retain copyright but grant the Gallery permission to reproduce the work, without charge, in connection with the online Learning Gallery and Saatchi Gallery social media accounts.
